

**NOTICE OF CITY COUNCIL PUBLIC HEARING**  
**115 EAST BROADWAY**  
**CREATIVE SIGN FOR KING TACO**

**NOTICE IS HEREBY GIVEN:**

**Project Location/Description**

King Taco restaurant, located at 115 East Broadway, is proposing a Creative Sign on the south elevation facing Broadway, approximately 50 feet west from the corner of the building. The sign is uniquely shaped in the cartoon form of a King Taco. When boxed, the projecting sign is approximately 62 inches wide and 84 inches tall. In addition to the unusual shape, the sign features neon tubing (red tubing outlining the shape of the sign and gold tubing within the crown), as well as reflective metal discs in what is supposed to be the butcher's cleaver.

**Entitlement(s) Requested**

**Creative Sign - Design Review Case No. PDR 1510788** – The Creative Sign will be presented to the City Council for Design Review approval, per GMC 30.33.225.

**Environmental Review**

The project is exempt from CEQA review as a Class 11 exemption, pursuant to State CEQA Guidelines Section 15311 Accessory Structures – On-premise Signs.
