*It is understood that per Glendale Municipal Code (GMC) [9.20.140](#) prohibits the consumption of alcoholic beverages in public parks and public property. Any person or persons not complying with the above ordinance may cause forfeiture of game in session and all remaining games with no refund.*

*It is understood that GMC [8.52](#) prohibits smoking on all City property including city parks and recreational facilities. Smoking includes the consumption of traditional tobacco products such as cigarettes, electronic devices such as “e-cigs” or “vape,” and it also includes other substances such as marijuana. These devices may or may not contain nicotine but are still prohibited from being used while on City property. The intent of this ordinance is to recognize the right of city residents, workers, and visitors to be free from unwelcomed secondhand smoke.*

*It is understood that unsportsmanlike conduct exhibited by any team, individual player, or spectator associated with the team may result in the suspension of either or all from the league for the remainder of the season and beyond. If **this situation should occur, fees will not be refunded.***

*It is understood that any forfeited games by my team will result in forfeit fees to be paid for by my team. It is also understood that non-payment of forfeit fees will result in banishment from the current league, any future City of Glendale leagues, and all F.I.F.A. or S.C.M.A.F. sanctioned leagues and tournaments for ALL TEAM MEMBERS.*

*It is understood that if my team drops out of the league at any time during the season after the game schedule has been distributed, my team and I are still responsible for payment of the full league fee which will not be refunded.*

*Team managers, coaches, and players who play in the basketball, softball and/or soccer leagues and whose teams have outstanding debts to the City of Glendale will not be allowed to participate in any City of Glendale Community Services & Parks adult sports leagues. In addition, team managers, coaches, players and/or teams will be reported to the F.I.F.A. & S.C.M.A.F. in which said participants will not be allowed to participate in any F.I.F.A. or S.C.M.A.F. programs and/or tournaments.*

*If a team manager, coach or player who owes said monies is found to be playing on or attempting to play in any league the team is subject to forfeiting all games played.*

*I understand that by signing this document I agree to be responsible for the payment of all my team’s fees. I also agree to represent my team’s players and spectators in all dealings with the league office at Pacific Park & Community Center and will be responsible for relaying all suspension information and instruction to all individuals associated with my team.*

I have read the above and am completely aware of its meaning. I will pass this information on to all members of my team.
