Youth & Family Services Background

The Youth & Family Services Section is designed to provide free information and referral services to at risk youth and their families. The section supports the family unit by providing guidance in decision making and by linking individuals with supportive services. Youth must be 13-17 years old or young adults within the ages of 18-21. No income or residency requirements needed. Self referrals, and referrals from other agencies are accepted.

Programs and Services

Teen Night Out

Teen Night Out occurs every Friday night from 5:00 p.m. to 9:00 p.m. rotating between two locations, Pacific Community Center at 501 S. Pacific, Glendale, CA 91208 or Maple Park Community Center at 820 E. Maple St. Glendale, CA 91205. Teen Night Out provides a safe place for teens to hang out and enjoy activities like video games, ping pong, computer lab, and karaoke. Light refreshments are served.

Annual High School Resource Fair

The Annual High School Resource Fair provides an opportunity for students to receive information on how to pursue different career paths within the City of Glendale. The Resource Fair gathers various City Departments for one day of information sharing on the high school campuses. Students learn about various job opportunities within each department directly from the Supervisors of those positions, when to apply, the requirements and necessary experience.

Community Based Teen Volunteering

Community based teen volunteering provides teens the opportunity to volunteer for the City of Glendale. In order to qualify:

- Volunteers must be at least 14 years of age
- Provide one form of identification: CA Drivers License, CA ID card, U.S. Passport, Military ID or Green card
- Commit to volunteering 50 hours a year



Youth Case Management

Case Management provides valuable community based resources for teens and their families. After an intake process, case managers will provide each youth with a personalized assessment, a well developed case plan, and support with utility bill assistance, free homework support, guidance counseling, legal assistance, and employment assistance.

Juvenile Ultimatum Service Training (J.U.S.T.)

Youth who have to complete court mandated community service hours can complete these hours with the Youth & Family Services Section's J.U.S.T. program. Youth will be guided through community service learning programs, and will develop skills on how to positively interact with the community. J.U.S.T. clients are referred by local area Juvenile Probation officers.
